### Atlantic District of The Wesleyan Church Standing Rules

#### A. Principles

- The ministers and lay persons of the Atlantic District are and shall continue to be committed to holy living and heart purity. Only those actions and attitudes that speak the mind of Christ should be evidenced among us.
- 2. The ministers and lay persons of the Atlantic District are and shall continue to be committed to a spirit of unity and brotherhood that, in the spirit of Christ, transcends the consideration of personal bias based on history, geography, or tradition.
- 3. The ministers and lay persons of the Atlantic District are and shall continue to be committed to Kingdom building through evangelism and discipleship. Our program and budgets shall reflect our high priority to winning the lost and discipling new converts.

#### **B. District Conference Matters**

For a more complete overview of the duties and powers of the district conference, please see paragraphs 1075-1180 in *The Discipline of The Wesleyan Church (2022)*.

- 1. The Atlantic District fiscal year shall be from May 1 to April 30.
- 2. Local churches are encouraged to give reasonable financial assistance to their delegates and pastor when representing them at annual conference sessions.
- 3. District Board of Administration Members-at-Large Election

The District Board of Administration shall consist of twelve members, namely, the District Superintendent, the Assistant District Superintendent, the District Secretary, the District Treasurer and eight (8) Members-at-Large. In electing Members-at-Large, while being free to vote for any nominee, the district nominating committee and conference delegates shall be strongly encouraged to consider nomination / election so as to provide for provincial/state representation and lay/clergy parity according to the following formula which reflects our relative strength within

each geographic entity.

Maine 1 lay and 1 clergy New Brunswick 2 lay and 2 clergy

Nova Scotia/Newfoundland & Labrador/Prince Edward Island

1 lay and 1 clergy

4. District Board of Administration Stagge<mark>red Terms for Members-at-Large</mark>

All Members-at-Large shall be elected for three-year terms. Incumbents may succeed themselves at the conclusion of a three-year term if nominated and elected. Should a vacancy occur during any three-year term, such vacancy shall be filled by the DBA in accordance with existing provisions of The Discipline.

#### 5. Camp Board

The Camp Board shall consist of membership both full and honourary as appointed by the DBA upon the recommendation of the District Superintendent who shall serve as Chair or appoint another to do so. The DBA shall determine the structure and scope of authority of this advisory board.

6. Officer and Department Head Elections

The District Conference shall elect only those officers and boards as required by The Discipline or the District with the District Board of Administration authorized to fill all other positions. (The District Conference will elect the District Superintendent, District Secretary, District Treasurer, District Board of Administration Members-at-Large, National Conference and General Conference delegates.)

7. Year-End Fund Transfers

The strength and interdependence of our various district ministries are both recognized and celebrated. At the conclusion of each fiscal year, funds will be transferred upon the recommendation of the District Superintendent and ratified by the DBA, that will maximize our Kingdom impact as expressed in our core values and vision.

#### **C. District Ministerial Matters**

- 1. All ministers of the Atlantic District are expected to attend the District Conference and the Ordination Service. Satisfactory reason for any approved absence shall be provided in advance to the District Superintendent. All credentialled ministers appointed to local church service are strongly encouraged to attend Ministerial events. Lay staff in pastoral roles are also welcome to attend. Lead Pastors are expected to attend or to designate a credentialled staff member to represent the church.
- 2. All credentialed ministers appointed to a local church are expected to support the district camping program and to share in the work of the camp(s) as assigned. A cap of four credentialled ministers will be required per church but all will be welcome to serve at the discretion of the Lead Pastor. Satisfactory reason for any approved absence shall be provided in advance to the District Superintendent.
- 3. Each pastor when leaving a church, will provide for the incoming pastor a data base/information packet containing information as full and complete as possible on the pastoral charge.

#### D. Local Church and Pastoral Matters

For a more complete overview of pastoral responsibilities and local board of administration duties, please see paragraphs 750-782 in *The Discipline of The Wesleyan Church (2022).* 

- Pastoral recall votes shall be routinely conducted during the first two weeks of March. The meeting for an initial pastoral call will routinely be conducted anytime after the middle of March. Any pastor wishing to announce a resignation prior to March 1 may do so only after receiving the approval of the District Superintendent.
- The tenure of an outgoing pastor shall end on the second Sunday in July and the pastoral change shall routinely take place on the following Monday..
- 3. Churches calling a new pastor shall pay moving expenses and related costs such as immigration expenses and travel.
- 4. Each pastor shall be entitled to a minimum vacation per year with pay in accordance with years of service in the ministry according to the following formula:

1 - 5 years service – 14 days not to exceed 2 Sundays

6 - 10 years service – 21 days not to exceed 3 Sundays

11+ years of service – 28 days not to exceed 4 Sundays

Any year of service for which a pastor is entitled to vacation is calculated from the anniversary date of the first Sunday of employment. Vacation time is fully earned upon completion of each year of service. If a pastor leaves a church prior to the anniversary date, vacation will be given on a pro-rata basis. When a pastor leaves a church at the customary time of pastoral change, the church he/she has been serving is responsible for vacation time for that conference year. No church should at any time be expected to provide vacation time in the same year for both an outgoing and incoming pastor.

- 5. Up to ten days including one Sunday per year are available to staff, solo and lead pastors for conference attendance, professional development, and shared ministry experience. Staff pastors must have the approval of their lead pastor and solo and lead pastors must confer with their LBA. These are to be considered minimums and may be increased by local leadership as deemed appropriate.
- 6. Pastors should inform the Vice-Chair of the Local Board of Administration of any plans to be absent from the pastoral charge for more than three consecutive days.

#### 7. Sabbatical Leave:

- a. A sabbatical leave, with pay, of up to 30 consecutive days not to include more than four Sundays, and in addition to regular vacation is available to any solo or senior pastor after completing seven years of ministry or any multiple thereof in the current place of appointment.
- b. The specific timing of the sabbatical leave must be mutually agreed upon between the pastor and the LBA in consultation with the District Superintendent.
- c. The church is responsible for any cost incurred in filling the pulpit during the sabbatical leave.
- d. The pastor is responsible to spend a significant portion of

the sabbatical leave involved in a learning experience either formal or informal. The details of the learning experience component of the sabbatical leave are to be provided by the pastor to the LBA and District Superintendent when the dates of the sabbatical leave are being set.

- e. The pastor is responsible to file a report of the learning experience component of the sabbatical leave with the LBA and District Superintendent upon completion of said leave.
- f. If the learning experience component is in a formal setting, the LBA is requested to give consideration to assisting the pastor in the cost of attending such.
- g. If the learning experience component is an informal one to be pursued in a retreat setting, the Atlantic District will make accommodations at Beulah Camp available at no cost to the pastor during the sabbatical leave, subject to prior bookings.
- The LBA of any church having long-term staff pastors are encouraged to consider a sabbatical leave for such staff pastors in harmony with the general provisions of this resolution.

Atlantic District of The Wesleyan Church 137th Annual Conference Day's Proceedings

The One Hundred and Thirty-seventh Conference of the Atlantic District of The Wesleyan Church convened in the Tabernacle of Beulah Camp, Browns Flat, New Brunswick, on July 10, 2025, at 9:00 A.M.

#### Welcome:

District Superintendent Rev. Peter T. Moore extended a warm welcome to all delegates attending the 137th Atlantic District Conference.

Dr. Rick Christman, President opened the conference in prayer.

#### Call to Order:

The Conference Chair, Rev. Peter T. Moore, officially called the 137th Atlantic District Conference to order.

Welcome: Rev. Jeremy McDonald was introduced as the Conference Host. Roll Call ballots were distributed, and conference special guests were introduced, these included National Superintendent Dr. Stephen Elliott and Rev. James Winn representing Global Partners.

#### **Roll Call:**

There remains merit for the District Nominating Committee and District Conference to consider geographical representation on the DBA;

#### THEREFORE, BE IT RESOLVED:

With immediate effect, the Atlantic District Standing Rule B(3) be amended for compliance with the constitutional rights of Members as follows (red indicates additions):

### **Atlantic District Superintendent Report**

They just kept believing. It was game one of the NBA Finals. The Indiana Pacers had trailed in the score the entire game. But they just kept believing. Say it with me, "They just kept believing."

Now, on paper these teams were completely mismatched. Oklahoma City was the number 1 seed in the West and ranked as the #1 team in wins for the entire NBA with the regular season MVP and sailed through to the NBA Finals as expected. The Pacers were the 4th seed in the Eastern Conference and no one expected them to make it past the Bucks, the Cavs, or especially the Knicks. But – they just kept believing.

But here they were in game one of the Finals for the first time in 25 years. With less than three minutes to play they were down to the OKC Thunder by 9 points and had already clawed back from as much as a 15 point deficit in the 4th quarter. In the entire history of the NBA Finals, any team down by at least nine with under three minutes left had a record of 0-182. But they just kept believing. And then this happened...

After trailing for 47 minutes and 59.7 seconds, they just kept believing.



It was the Thunder's possession for the final play with only 0.3 seconds on the clock and they were fresh out of miracles. The Pacers silenced the Paycom Arena with a Game One W. NOW that comeback statistic for NBA playoff teams down nine or more in the final 3 minutes – reads 1-182. And Haliburton's Pacers stand alone in history because they just kept believing.

Before any hecklers build up their courage – let's be clear – we're not going to talk about Game Seven today or Haliburton's tragic demise for the next year with his achilles injury. However, if any of you want to talk about the incredible run of the Pacers in this year's playoffs in the break, I'd be happy to connect.

Here's a pic for those of you, like my future son-in-law Elijah, who were cheering for the wrong team.



The superstar of OKC – an amazing Canadian talent – Shai Gilgeous-Alexander who was the triple MVP of the year, had this to say after that amazing clutch shot in game one, "We had control of the game... Now, it is a 48-minute game, and (the Pacers) teach you that lesson more than anyone else in the league - the hard way."

It is a 48-minute game. And it reminds us of all the admonitions of Scripture that races are run to be finished. That faithful stewards just keep believing in the next shot God gives us to take. Faithful stewards do what? They just keep believing. We fight the good fight. We finish the race. As those called to Kingdom leadership when we do not grow weary in doing good, at just the right time we will reap a harvest of blessing if we don't give up. We just keep believing.

The remainder of my report will include our second-year Meductic Mandate update, a word about some 2025 statistics, and two special highlights, and some final words of appreciation.

Here is a reminder of the District Vision to raise and release disciple-making leaders we launched two years ago at Conference...




Our Meductic Mandate – 400 Leaders by 2027

The supplementary material in the folder for my report gives a detailed overview of this journey. All Delegates received advance access to the document, "Why the Meductic Mandate?" Thank you for taking the time to pre-read this so you understand the context of our journey together. Our Meductic Mandate is fulfilled each time we call, cultivate, and commission a disciple into a disciple-maker who owns the mission for transformed lives into one of the four quadrants of Christ's missional mandate in Acts 1:8.

- Some disciple-makers will have a primary call within the walls of our local churches. This is *Jerusalem* the HERE quadrant.
- Some will have a primary passion to make disciples outside the walls in our communities or through their workplace influence. This is Judea – the NEAR quadrant.
- Others will feel compelled to give their best and most to disciple Samaria

   the HARD quadrant. Those who are near but different or difficult
   to reach. This may include multicultural work or serving families with
   special needs loved ones or making disciples with those dealing with
   addictions, homelessness, trafficking, or incarceration.
- And finally, some will feel called to invest in reaching the Ends of the
  Earth the FAR quadrant. These disciple-makers include those who
  strategically lead our local churches to interdependence with the global
  Church as well as those who feel God is calling them to actually go and
  serve as short-term and/or long-term missionaries.

So, with this very brief reminder, here are the Year Two results of our Meductic Mandate.




Year TWO – 400 Disciple-Making Leaders

Every number in this chart was submitted as a list of actual disciple-makers by name. These were double-checked with the names submitted last year to make sure no one is being counted twice. Thank you to every Lead Pastor who shared the names of the new disciple-making leaders under your watch who are being raised and released.

As you can see, the numbers doubled this year in the leadership pipelines of our churches from 156 to 311. As the story of the Meductic Reformed Baptist Church inspired us to call, cultivate, and commission, over the past two years we have already exceeded our four-year goal with 457 disciple-makers raised and released.

This is a huge win for the Kingdom in our Atlantic region. I love the vision of my friend and DS colleague Chris Conrad of the Great Lakes Region about raising and releasing disciple-making leaders. Chris dreams of a time in our churches when the three most important days on the calendar each year are Christmas, Easter, and Commissioning Sunday. Imagine what would happen in the Atlantic region if every church had at least one Commissioning Sunday each year to acknowledge and release those who have been raised up as disciple-makers in their personal calling to one of the four quadrants of the harvest?

You see, the numbers we can count are at the cross in the middle. Salvations and baptisms. They are what the book the *Discipline of Execution* calls the lag measures or what we might call Kingdom fruitfulness. But all the things that need to happen on the left-and-right-part of that arrow, are the *lead* measures of disciple-making we might call Kingdom faithfulness. Nearly impossible to measure, super contextual based on the individual and their own journey of spiritual growth and life circumstances.

I got a text recently from Vince Roberton at West Head Wesleyan that perfectly captures what it looks like to lean into these lead measures a disciple-maker leader. I love the passion in his heart as an evangelist as he shared about a man on Cape Sable Island. How this man has been clean from addiction for the past six months and in Vince's words, "Is on his way to faith. His family back together." Vince has been reaching out to him over the past seven years. You can't put that in a Local Church Statistical Report, **but** it is why we do what we do and it is worth celebrating.

Bobby Harrington of Discipleship.org reminds us – Jesus didn't say, "Go and get more people in the seats." He said, "Go and make disciples."

As the DBA reviewed this progress of Year Two in our Meductic Mandate, we agreed we will have a singular focus on one thing for FY2026 to be our final year of the Meductic Mandate as we prepare in our strategic plan to move on to the next district vision priority in how we will work together to multiply new Kingdom locations.

So, what is that one thing? We are calling on every Kingdom location in the Atlantic Tribe to have at least one *Commissioning Sunday* before Beulah next year. If you were in the Tabernacle on Tuesday night you already know what


I'm talking about. You will be hearing more about this from me later in the summer. But before we dive into a sneak peek at our ongoing multiplication conversation, let's take a brief look at some of the statistical highlights of this year.

#### By the Numbers - Some 2025 Statistics


Church, we have some Holy Spirit transformation over this past church year to celebrate. Remember, every number has a name, and every name has a story that matters for eternity for God's glory. It's about unleashing churches for transformed lives. Here are some key statistics to acknowledge.

- First and foremost let's talk about the people going to heaven this year who did not have that assurance before. 645 decisions to follow Jesus were reported – Praise the Lord!!!
- Of the 63 Kingdom locations across our district, there were 7 churches with no reported salvations this year. This is one more than last year and has taken a small step in the wrong direction. We will not be satisfied until this is zero churches. Lord, make it so as we labour in your harvest fields!
- There were 556 baptisms across our 63 Kingdom locations. While there
  were 8 churches with no baptisms this year this is down from 12 last
  year and 17 in 2023. This is trending in the right direction.
- Last year, our primary worship average attendance jumped 5% to 9,239 with nearly 60% of our churches holding their own or experiencing growth. This is only about 200 people less than the pre-pandemic high water mark of attendance.

You all received an advance copy of a multiple-page statistical summary of how God has been at work in our Atlantic Tribe over this past church fiscal year ending April 30th. These lists and charts are a simply a snapshot in time of the **faithfulness** and **fruitfulness** of our Kingdom colleagues and church families across the Atlantic region.




Encounter Church with Jim Agrell celebrated 38 eternal souls finding hope and life in Jesus this year. They had the 4th highest number of any church, but when you factor in the size of their congregation it scales to be the most fruitful context we experienced this year in any of our Kingdom locations.



River Valley Wesleyan with Darren Clark had 7 baptisms – PTL! And while they were not even in the top ten of actual baptisms, the context of their current scope of impact gave them the highest per capita outcome by far of any of our churches this year. Yarmouth Wesleyan (AJ Plaizier) led the per capita baptisms for our larger churches & Kings with Brent Ingersoll's expanding team continues to set pace for our larger congregations as the only church in the 500+ range to make both of these per capita reflections of fruitfulness.

Statistics like these remind us that we steward not just a personal *calling* – but we steward a particular *context*.



When you add the number of people saved with the number of people baptised this past church year as a percentage of your church's primary worship attendance average, it scales fruitfulness. Churches like Encounter and The River in Bangor (Mark Soone) are modeling for us how to best multiply the talents we have received from the Master.

He called you to finish the race He has for you. Do not grow weary and lose heart, just keep believing.

### Riverside Camp Director Report

I reported this time last year that Riverside had completed a full renovation of our girl's dorms which included all new mattresses, bunks and furnishings. I also stated that at the time of district conference we had reached pre-covid numbers of campers. I am pleased to inform you that last fall we were also able to completely gut, paint and rebuild the inside of our boy's dorms. This included building all new bunks, walls and putting in new doors. Thanks to the resourcefulness of our Board members, long time attenders of Riverside and churches throughout Maine in 2024 we were able to renovate both our Girl's & Boy's Dorms. Most notably this was done for less than what we had budgeted to complete the renovation of just one of the camper dorms. At the same time this came at no cost to the camp. I am truly grateful to have witnessed a significant amount of generosity towards Riverside over the last year.

Furthermore in 2024 Riverside hosted a one-day family event in June that has now turned into a weekend event called "Riverside Days." Over the course of this weekend our aim is to offer a full and immersive experience of what Riverside is truly like. For all ages at that. At the same time last fall, we held our first-ever fall retreat for Middle School and High School Students. With the help of Shaun Miller and the Praxis students we were able to offer a weekend disconnected from the rest of life for students to connect with Jesus and each other. With the addition of these two weekends, it has in my opinion bolstered both the ministry effectiveness of the Camp for Central Aroostook County and has greatly helped to move riverside to a place of greater sustainability.

With this being said, throughout the spring of 2025 we have renovated our dining hall, bathrooms, and begun phase one of upgrading our kitchen. We have also begun work on leveling ground for a new rec field which will also double as added parking for staff and visitors. With all the work that has been done in the last year and this past spring, our Camp Board has achieved THREE years of our renovation plan in just 18 months! The purpose of these renovations is to both create a more hospitable and comfortable environment for our campers and guests (without losing Riverside's humble charm) while at the same time making Riverside a more viable event venue to offer to our community which will help with sustainability and allow us to keep Camper costs down.

Currently as of June first our Camper registrations are up from 2024 as well. The last Camping Season was a big step in the right direction for Riverside and 2025 is shaping up to be another pivotal year in the life and ministry of this Camp.

### **District Clergy Care Coordinators Report**

We have been honoured to come alongside many individuals or couples this past year to offer care through coaching and counselling. Whether it be online or in-person, individually or with a ministry couple coming for a day or multi-day experience, God has brought hope and healing to many.

At last year's District Conference, we shared about a task team addressing important questions. The DBA received two reports – one in November 2024 and one in April 2025 – answering two questions:

- 1. What is the best standard of care the Atlantic District can offer to those who are in crisis?
- 2. How can we cultivate a healthy culture of care and safety for those serving under District appointment?

These meetings and consultations have led to a comprehensive approach, combining both preventative and restorative strategies, all under the heading "Care Resources to our Pastors and their Families." We are so pleased to see this new development for those serving in the Atlantic District.

#### **NEW: Accessing Care Resources on the District website**

#### **NEW: Clergy Care Advocate**

Rev. Dave Higle will be serving as our Clergy Care Advocate (CCA). The CCA offers a safe, confidential space for pastors to talk about any immediate needs or concerns. The CCA helps assess each situation and connects pastors with the most helpful resources. All conversations remain completely confidential. The CCA is to serve primarily under the Restorative track.

**NEW: Flourishing in Ministry Assessment** 

An important assessment will run from October 7–22, 2025. Every pastor is asked to participate to help us gather a District-wide picture of clergy well-being. While some of you may have taken a similar survey in the past, it did not provide District-specific results. You will receive a code specific for taking this as a group. Key recommendations and a follow up with Dr. Chris Adams will be presented to the DBA in November and the clergy at the District Ministerial in January 2026.

#### Counselling and Coaching available for Atlantic District Pastoral Families

#### **Canadian Pastors and Immediate Dependent family members:**

 The Atlantic District will provide for pastors (and immediate dependent family members) appointed to our local churches, up to three counselling/coaching sessions each, per year. These are confidential sessions billed anonymously, with no names included.

#### Additional counselling sessions for those with Blue Cross:

Jay is a Blue Cross provider (other insurance providers may apply as well). This
is an excellent option to continue care beyond the three sessions provided by
the District. There is a small co-pay pay based on the extended benefits under
Blue Cross.

#### State of Maine Pastors and Immediate Dependent family members:

 Pastors and their immediate family members serving in Maine are eligible for up to five counselling/coaching sessions each, per year, since they are not covered under the District Blue Cross plan.

#### **Booking Sessions:**

 Sessions can be booked virtually, or in-person based on location, distance and schedules.

#### A Come-Away Experience (Intensive)

 A retreat experience is available offering one-on-one or couple-to-couple sessions, depending on your needs. Accommodations at Beulah Camp are provided. You will need cover travel and meals, with at least one shared meal with the Guptills included, if desired.

### 2025 District Treasurer's Report

Where God guides, He provides! This report provides a clear overview of our district's financial health over the past year. By God's provision and your faithful stewardship, we have remained financially stable while supporting vital ministries. Together, we continue to invest in Kingdom work with transparency, accountability, and a heart for eternal impact.

The overview that follows provides a snapshot of our district financial position at the end of FY2025. The collapsed Balance Sheet & Profit/Loss Statement for our three accounting classes of Beulah, Caton's Island, & District Operating are available in your Virtual Conference Packet. Any delegate is welcome to receive further information regarding these reports upon request. Our 2025 year-end fiscal statements have been reviewed by Ascend Chartered Professional Accountants of Sussex, NB. This positive review did not contain any material qualifications requiring action and will be examined for approval by the DBA when it convenes on Wednesday, July 9th. This District Treasurer's review of our financial statements will also appear on our website in the 2025 District Journal published on or before the end of August.

Here are a few *Noteworthy Highlights* from FY 2025:

- Over the past five years as a district family who faithfully pays USF and with Metro's sacrificial investment in the BLT location, we have Partnered in Mission for Kingdom multiplication for a total of more than \$650,000 in partial support of the launch of eight new Kingdom locations in our region! This current fiscal year is the second of the General Conference mandated USF investment in which a portion of last year's income will be invested in Kingdom multiplication. Our DBA proposal has been approved by the General Superintendent which includes partnering with New Hope Wesleyan in the fall launch of a Windsor location and with Deep Water in the fall launch of their Woodlawn location. We have heard from our new Directors of Multiplication in our DS's report about the vision of the existing Multiplication Networks to launch at least four new locations in the next two years as well as other strategies for new Kingdom locations. Our church multiplication reserves are strong to support many more in the years ahead.
- 2. Our USF collection rate dipped slightly to 92.1%. However, nearly every church participated in meeting this obligation, and all but nine churches gave 100%. We are blessed with Kingdom leaders who can be trusted to honour their commitments. Your faithfulness is deeply appreciated and makes an enormous difference in the district's capacity to serve our churches and pastors.
- 3. The flow of funds through the district office during the year for all purposes exceeded \$4.6M a new all-time high. It should also be noted that the USF for FY2025 obligations assigned in the Virtual Conference Packet represent a decrease of over \$66K distributed among seven capped churches with assessable income exceeding annual assessable revenue of Tier One at \$537,500. This is a continued result of the action of the 2017 District Conference to lower the district assessment rate beyond denominational requirements by an additional 1% for Tier Two and an additional 2% for Tier Three.
- 4. The rental continuity of Wesleyan Place, our District Office in Moncton has proven to be a phenomenal asset for serving our district leaders and churches with a net cost to the district of less than \$800 per month.

- 5. Beulah and Caton's Island had a combined income of more than \$2.6M and the district operating fund just under \$2M with a combined total in our three accounting classes of more than \$4.6M. Our Executive Administrator Karrilee Bremner is to be commended for her outstanding efforts in managing this massive task with such grace and diligence. She is an exceptional gift to our district.
- 6. Caton's Island ministry continues to expand with the addition this year of a new Administration Building which will also house the medic station and family. When the upstairs portion is complete it will include boys & girls dorm space for an additional 36 summer staff. As capital projects are receiving unprecedented levels of financial support, in FY25 for only the second-time ever, total revenue for Caton's Island exceeded that of our Beulah class. We were only 15 registrations short last summer of Director Dean Stephenson's 2025 Vision to see 2,025 registered campers who stay at least one night and hear the Gospel at least once. The growing number of campers is providing increased stability, and the fiscal outlook has never been stronger.
- 7. Financial partnership with the International Wesleyan Church occurred through 21 projects and 31 missionaries in 18 countries. The top nine churches on our district are listed in the Global Partners report in your Virtual Conference Packet. The support for World Hope International Canada will be highlighted later in our business in a report from CEO Tanya Nace.
- 8. The WIF loans contain residue balances of just over \$900K from several projects including Heritage Hall, Centennial Park, River Haven, Wesleyan Place and the Tabernacle expansion. However, by far the largest component in this balance is the funding of the state-of-the-art wastewater system which serves continued growth and future possibilities for Beulah Camp and Conference Center operations.
- 9. Our district reserves remain at healthy levels to mitigate unexpected challenges and expenses for a variety of matters. This includes our medical reserve which remains strong to assist in uncovered health emergencies. Thousands of dollars are also invested each year in serving other confidential challenges our pastoral families face. We are blessed to be able to make a real difference in their lives because of your commitment to USF in support of our district ministry.

We praise God for His provision. The year-end fiscal position of the Atlantic District continues to provide a solid foundation for the foreseeable future as we seek God for wisdom to invest these resources in our shared mission to unleash churches for transformed lives!
